### Guide to Joining the FMEC

**Bronze Level (\$1,000)** If you are an **individual family medicine residency (FMR)** and plan to participate in the FMEC Residency Fair and/or the FMEC initiatives to support meeting ACGME requirements, join at the Bronze (\$1,000) Level.

If you are a **medical school** and your students want to attend the FMEC Annual Meeting on FMEC scholarships, join at the Bronze (\$1,000) Level. *(As of 2022, the requirement for medical schools to be partners for their students to receive scholarships will be enforced.)*

**Silver Level (\$2,500)** If your **residents and faculty attend and/or present** at the FMEC Annual Meeting, join at the Silver (\$2,500) or Gold (\$5,000) Levels, so they receive individual FMEC memberships and get discounts on meeting registrations.

If you need to **advertise jobs and fellowships** to 5,000+ health care providers throughout the northeast, join at the Silver (\$2,500) Level or higher.

**Gold Level (\$5,000)** If your system has **multiple FMRs** who want to participate with FMEC, join at the Gold (\$5,000) Level or higher to enroll your FMRs as Bronze Partners.
